ORDINANCE NO. 14 – 10

TO AMEND THE 2014 ANNUAL BUDGET APPROPRIATIONS; TO ESTABLISH A NEW BUDGET FUND; AND TO DECLARE AN EMERGENCY.

WHEREAS, on March 18, 2014, by Ordinance No. 14-9, this council set the annual budget appropriations for calendar year 2014; and

WHEREAS, because of unforeseen revenues and expenses, it has now become necessary to amend the previously set appropriations;


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The sum of \$1,000.00 shall be transferred from the General Contingency Fund (Fund no. 101) to the Cheviot Swimming Pool Fund (Fund no. 502).

Section 2. There is hereby established a new fund to be known as the “Indigent Drivers Alcohol Monitoring Fund.” It shall be fund number 215. In addition, there shall be a corresponding revenue line item known as budget line item no. 215.121.1, Revenue – State Reimbursements, and a corresponding expense line item known as budget line item no. 215.101.225.1, Expenses-Court Ordered Monitoring Device.

Section 3. The sum of \$600.00 shall be appropriated to budget line item no. 215.101.215.1.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to properly account for its revenues and expenses at the earliest possible time.
