ORDINANCE NO. 14 – 13

TO APPROVE THE BID SUBMITTED BY THE J.K. MUERER COMPANY FOR THE RESURFACING OF THE TENNIS COURTS AT THE CHEVIOT FIELDHOUSE; AND TO DECLARE AN EMERGENCY.

WHEREAS, on April 1, 2014, by Resolution No. 14-9, this council directed the Safety-Service Director to solicit bids for the resurfacing of the tennis courts at the Cheviot Fieldhouse; and

WHEREAS, the Safety-Service Director advertised as required by law and received two qualifying bids; and

WHEREAS, of the two bids received, the lowest and best bid was submitted by the J.K. Muerer Company;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The bid of the J.K. Muerer Company in the base amount of \$49,200.00 (with an alternate price of \$98,165.00) is hereby accepted.

Section 2. Upon review and approval of the Law Director, the Safety-Service Director is authorized and directed to enter into a contract on behalf of the City of Cheviot with the J.K. Muerer Company, in accordance with the specifications on file in his office and subject to budget appropriations.

Section 3. In the event of unforeseen circumstances requiring work over and above the contract price, the Safety-Service Director shall not approve any additional work exceeding 10% of the bid amount without first receiving authorization from the city council.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to keep its recreational facilities in the safest possible condition.
