ORDINANCE NO. 14 - 23

TO AMEND THE 2014 ANNUAL BUDGET APPROPRIATIONS; TO CREATE A NEW BUDGET FUND AND LINE ITEMS; TO TRANSFER FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to properly account for certain city expenditures, both expected and unforeseen, it has now become necessary to amend the previously enacted budget appropriations;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. There is hereby established a new budget fund. It shall be titled the "Robb Avenue Street Construction Fund" and shall be Fund No. 219. Within that fund shall be two budget line items: Revenue (#219.121.1) and Expense (#219.608.239.1).

Section 2. The following budget line items shall be increased by the amounts indicated:

219.608.239.1	Robb Ave. Construction Expense	\$161,868.00
201.603.234.1	SCMR Auditor & Treasurer Fees	75.00
101.506.235.2	Public Works Equip. Maintenance	10,000.00
101.715.270.1	General Fund – Transfers Out	55,000.00
201.603.242.1	SCMR Snow Removal	55,000.00

Section 3. The following budget line items shall be decreased by the amounts indicated:

201.602.249.1	SCMR Misc. Supplies & Materials	75.00
101.506.252.1	Public Works Equip. > 5 Years	10,000.00

Section 3. The sum of \$55,000.00 shall be transferred from the General Fund to the SCMR Snow Removal line item for the purchase of ice control salt.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet its financial obligations in a timely manner.
