ORDINANCE NO. 14 – 27

TO AMEND THE 2014 ANNUAL BUDGET APPROPRIATIONS; AND TO DECLARE AN EMERGENCY.

WHEREAS, it has become necessary for the Council of the City of Cheviot to amend the previously enacted 2014 budget appropriations;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The following budget line items shall be increased by the amounts indicated:



Section 2. The following budget line items shall be decreased by the amounts indicated:

101.714.212.4	Insurance	\$ 7,900.00
502.305.234.1	Pool Salaries	1,200.00
101.714.237.1	Energy Efficiency Debt	11,000.00
301.202.261.1	Ambulance Principal	.25
<b>Total Decrease</b>		<b>\$ 20,100.25</b>

Section 3. The sum of \$11,000.00 shall be transferred from the General Fund (Transfers Out, budget line item no. 101.715.270.1) to the Energy Efficiency Project Fund (budget line item no. 302.202.252.1).

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City of Cheviot to meet its financial obligations in a timely manner and to properly account for receipts and expenses.






