ORDINANCE NO. 14 - 8

TO SET NEW RATES FOR THE USAGE OF CITY FACILITIES AT THE HARVEST HOME PARK AND THE CHEVIOT FIELDHOUSE; AND TO DECLARE AN EMERGENCY.

WHEREAS, on April 16, 2013, by Ordinance No. 13-5, this council set new rates for the usage of the city facilities at the Harvest Home Park and the Cheviot Field House; and


WHEREAS, on January 1, 2014, by Ordinance No. 14-1, this council revised those rates for the usage of the city facilities at the Harvest Home Park and the Cheviot Field House; and

WHEREAS, this council has received feedback from the community regarding the previously set rates, has conducted additional research regarding the cost to operate the municipal facilities, has compared the city's rental rates with those of neighboring political jurisdictions, and has determined that some changes to the existing rates are necessary;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. There is hereby approved a new rate schedule for the usage of the city facilities at the Harvest Home Park and the Cheviot Fieldhouse. A copy of the new rate schedule is attached hereto and made a part hereof as "Exhibit A." The new rates shall be effective for all new contracts issued by the Recreation Commissioner. Existing contracts shall continue at the rate in effect at the time of the contract.

Section 2. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to remain competitive in the provision of recreational facilities.
