ORDINANCE NO. 15 – 15

TO AMEND THE 2015 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, the budget appropriations recently enacted in Ord. 15-9 are in need of amendment;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. Budget line item number 305.101.252.2 (Auto Equipment > 5 years) shall be added to the 2015 annual budget appropriations in order to properly account for the purchase of a new dump truck for the Public Works Department.

Section 2. The following budget line items shall be increased by the amounts indicated:



Section 3. The following budget line items shall be decreased by the amounts indicated:

706.111.251.2	JEDD II Green Township Share	\$ 1,500.00
705.111.251.2	JEDD Western Ridge Green Township Share	1,000.00
707.111.251.2	JEDD III Green Township Share	33,641.76
Total decrease		<u>\$ 36,141.76</u>

Section 4. The sum of \$2,000.00 shall be transferred from the General Contingency Fund (Fund No. 101) to the Swimming Pool Fund (Fund No. 502).

Section 5. This ordinance shall be an emergency measure for the health, safety and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to properly account for its receipts and expenditures.




