ORDINANCE NO. 15 – 23

TO TRANSFER FUNDS; TO AMEND THE 2015 ANNUAL BUDGET APPROPRIATIONS; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to pay certain city expenses it has become necessary to transfer funds between several budget line items;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The sum of \$10,000.00 shall be transferred from the General Contingency Fund (Fund No. 101) to the Swimming Pool Fund (Fund No. 502) in order to pay end of year expenses.


Section 2. The following budget line items shall be increased by the amounts indicated:

502.305.231.1	Pool Utilities	\$ 3,500.00
502.305.234.1	Wages	1,800.00
502.305.249.1	Contract Incidentals	4,700.00
101.302.270.1	Harvest Home Playground	3,000.00
101.101.234.1	Police Dept. Professional Services	10,000.00
101.101.244.1	Police Dept. Equipment < 5 years	5,000.00
Total Increase		<u>\$ 28,000.00</u>

Section 3. The following budget line items shall be decreased by the amounts indicated:

101.714.234.2	Elections deductions	\$ 3,000.00
101.101.211.2	Police Dept. part-time salaries	15,000.00
Total decrease		<u>\$ 18,000.00</u>

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet its financial obligations in a timely manner.


