ORDINANCE NO. 16 – 18

TO AMEND THE 2016 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, on March 22, 2016, by Ordinance No. 16-4, this council set the annual budget appropriations for calendar year 2016; and

WHEREAS, since the passage of Ordinance No. 16-4, this council has from time to time enacted amendments to the appropriations and made internal fund transfers in order to account for changes in revenue or to meet changes in city expenses; and

WHEREAS, it has become necessary to make further adjustment to the budget line items of the city;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The following budget line items shall be increased by the amounts indicated:

Section 2. The following budget line items shall be decreased by the amounts indicated:

Section 3. Budget line item no. 101.302.270.2 (Harvest Home Refunds) shall be increased by \$700.00. This amount will be added to the Certificate of Available Resources.


Section 4. The Energy Efficiency Principal Account shall be budget line item number 302.202.250.1.

Section 5. Fund number 226 shall be renamed "the Westwood Northern Boulevard Reconstruction Fund," and budget line item number 226.608.221.1 shall be added with an appropriation of \$146,300.00.


Section 6. The sum of \$4,067.00 shall be transferred from the General fund to the Sidewalk Fund.

Section 7. The sum of \$124.00 shall be transferred from the General Contingency Fund to the Ambulance Fund (Fund No. 301) for loan repayment purposes.

Section 8. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet its financial obligations in a timely manner.






