ORDINANCE NO. 16 – 19

TO AMEND THE 2016 ANNUAL BUDGET APPROPRIATIONS; AND TO DECLARE AN EMERGENCY.

WHEREAS, on March 22, 2016, by Ordinance No. 16-4, this council set the annual budget appropriations for calendar year 2016; and

WHEREAS, since the passage of Ordinance No. 16-4, this council has from time to time enacted amendments to the appropriations and made internal fund transfers in order to account for changes in revenue or to meet changes in city expenses; and

WHEREAS, it has become necessary to make further adjustment to the budget line items of the city;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The following budget line items shall be increased by the amounts indicated:

Fire Dept. Equipment > 5 years	101.102.252.1	\$ 31,678.88
JEDD Harrison Greene (Cheviot Share)	708.111.251.1	81.00
JEDD Harrison Greene (Green Twp. Share)	708.111.251.2	721.00
JEDD Colerain/Liberty (Cheviot Share)	709.111.251.1	800.00
JEDD Colerain/Liberty (Colerain Twp. Share)	709.111.251.2	7,190.00

Total Increase		\$ 40,470.88

Section 2. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet its financial obligations in a timely manner and to allow the city to properly account for changes in revenue.
