RESOLUTION NO. 14 - 15

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO ADVERTISE FOR BIDS FOR THE SALE OF THREE ITEMS OF PROPERTY WHICH ARE NO LONGER NEEDED FOR MUNICIPAL PURPOSES; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City of Cheviot has three pieces of equipment which are no longer needed for municipal purposes; and

WHEREAS, the fair market value of each of those items is estimated to be above \$1,000.00; and

WHEREAS, Section 721.15 of the Ohio Revised Code requires that such items be disposed of after advertisement and the receipt of competitive bids;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. This council hereby authorizes and directs the Safety-Service Director to advertise for bids for the sale of the following items of property:

- 1) American Road Machinery pull-behind leaf collector with wooden box;
- 2) 1974 Ford F700 with Good Roads leaf collector;
- 3) 1995 Chevrolet 2500 pickup with plow attachment.

Section 2. Upon receipt of the bids, if any, the Safety-Service Director shall submit the bids along with his recommendation to this council for acceptance or rejection.

Section 3. The Safety-Service Director may set reasonable restrictions on the bids, such as time for performance, method of payment, etc.

Section 4. In the event that, after advertisement for two weeks, no bids are received for any item of equipment by the specified deadline, the Safety-Service Director may advertise that item of equipment in a classified advertisement for any amount he deems reasonable and accept any reasonable offer he receives.

Section 5. The proceeds of any sales made pursuant this resolution shall be deposited to the general fund of the city.

Section 6. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to dispose of unneeded municipal property at the earliest possible time.


