RESOLUTION NO. 15 – 10

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO SEEK BIDS FOR THE SUPPLY OF ICE CONTROL SALT THROUGH A JOINT BID WITH THE CITY OF CINCINNATI; AND TO DECLARE AN EMERGENCY.

WHEREAS, Section 735.053 of the Ohio Revised Code permits separate political subdivisions of the State of Ohio to contract with each other for the purchase of materiel, equipment, supplies, and services without advertising and competitive bidding; and

WHEREAS, the Safety-Service Director has communicated with the City of Cincinnati about the availability of participating in its bid for the purchase of ice control salt; and

WHEREAS, because of Cincinnati's greater buying power, it is most likely that the City of Cheviot would save money by being a party to a larger bid proposal; and

WHEREAS, this council believes that the City of Cheviot would benefit by requesting inclusion in the bid of the City of Cincinnati for ice control salt;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The Safety-Service Director is authorized and directed to request that the City of Cincinnati include in its request for salt bids an amount of additional salt that would be sufficient for the needs of the City of Cheviot for the 2015 – 2016 winter season.

Section 2. Upon finalization of the bid, this council will make the necessary appropriation for the expenditure in accordance with Section 735.053 of the Ohio Revised Code.

Section 3. This resolution shall be an emergency measure for the health, safety and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order

to allow the City of Cheviot to be included in the bid process being initiated by the City of Cincinnati.
