RESOLUTION NO. 15 – 16

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO SELL THE CITY'S 1988 SEAGRAVE QUINT LADDER TRUCK TO HANOVER TOWNSHIP, OHIO, FOR AN AMOUNT NOT LESS THAN \$10,000.00 ; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City of Cheviot has recently acquired a new quint fire truck; and

WHEREAS, the older quint fire truck is no longer needed for municipal purposes; and

WHEREAS, the Safety-Service Director has caused an advertisement for the sale of the 1988 Seagrave quint fire truck to be made since May of 2015; and

WHEREAS, the only offer received for the vehicle has been a \$10,000.00 offer from Hanover Township, Ohio; and

WHEREAS, there is a very limited market for older used fire trucks, and it is unlikely that the City of Cheviot will receive a better offer for the vehicle;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:


Section 1. The Safety-Service Director is hereby authorized and directed to sell the city's 1988 Seagrave quint ladder truck to Hanover Township, Ohio, for an amount not less than \$10,000.00.

Section 2. The Safety-Service Director is authorized to execute the necessary paperwork and deliver a certificate of title to the purchaser.

Section 3. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to dispose of unneeded equipment at the earliest possible time.
