RESOLUTION NO. 15 – 21

TO RESCIND AN EXISTING 1.5 MILL ROAD LEVY; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City of Cheviot currently has in place a 1.5 mill levy for road improvements which was affirmatively voted upon by the electors of the city on November 8, 2011; and

WHEREAS, on May 5, 2015, the electors of the city approved a new 3.0 mill road levy based upon the promise of the city council that, if passed, the existing 1.5 mill levy would be rescinded; and

WHEREAS, Section 5705.19(YY)(4) of the Ohio Revised Code specifies that an existing levy may be terminated by a resolution of council;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. There currently exists a 1.5 mill road levy which was approved by the electors of the City of Cheviot on November 8, 2011. The levy began on January 1, 2012, and was to continue for five years, terminating on December 31, 2016.

Section 2. The continuance of the levy is unnecessary, and the levy shall be terminated at the same time that the new levy, enacted May 5, 2015, takes effect.

Section 3. The Clerk of Council shall cause a certified copy of this resolution to be forwarded to the Hamilton County Auditor, and take all necessary steps to have the 1.5 mill levy removed from the tax records.

Section 4. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the unnecessary tax levy to be terminated before the new tax levy takes effect.
