

**CITY OF CHEVIOT

RESOLUTION NO. 15 – 22

TO REQUEST THAT THE HAMILTON COUNTY AUDITOR CERTIFY TO THE CITY OF CHEVIOT THE TAX LEVY CALCULATIONS ENUMERATED IN SECTION 5705.03(B) OF THE OHIO REVISED CODE; AND TO DECLARE AN EMERGENCY.

WHEREAS, it is the intention of the legislative authority to renew a tax levy at a rate of 3.00 mills, whose purpose is to meet current expenses of the City of Cheviot in accordance with Sections 5705.19(A) and 5705.05 of the Ohio Revised Code; and

WHEREAS, it is the intention of the legislative authority that the tax levy be voted upon at the primary election on March 15, 2016;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. This council has determined that it is necessary to levy a tax outside of the ten-mill limitation for the purpose of meeting current expenses in accordance with Sections 5705.19(A) and 5705.05 of the Ohio Revised Code.

Section 2. This council hereby requests that, pursuant to Section 5605.03(B) of the Ohio Revised Code, the Auditor of Hamilton County, Ohio, certify to the City of Cheviot, within ten days of the receipt of this resolution, the following information:


- A. The total current tax valuation of the City of Cheviot;
- B. The dollar amount of revenue which would be generated by 3.00 mills.

Section 3. This council further specifies the following information regarding the proposed tax levy:

- A. Purpose of Levy. The purpose of the proposed 3.0 mill levy shall be for current expenses of the City of Cheviot as authorized by Sections 5705.19(A) and 5705.05 of the Ohio Revised Code.
- B. Type of Levy. The proposed 3.0 mill levy shall be a renewal levy authorized by Section 5705.19(A) of the Ohio Revised Code.
- C. Calendar Year in Which Levy is Due. The proposed 3.0 mill levy shall first become due in calendar year 2017.
- D. Term of Levy. The term of the proposed levy shall be five years.

Section 4. Upon passage of this resolution, the Clerk of Council shall immediately certify a copy of it to the Auditor of Hamilton County, Ohio.

Section 5. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to comply with the time requirements of Chapter 5705 of the Ohio Revised Code and in order to ensure that the proposed levy appears on the March 15, 2016, ballot.


