The meeting was called to order at 7:33 p.m. with the Pledge of Allegiance and a moment of prayer. Roll call was taken and the following were found in attendance:

There was a motion to excuse Mrs. Gooch and Mr. Mastruserio made by Mr. Mestemaker with a second by Mrs. Goedl. The motion carried 5-0 by voice vote. The minutes of the February 20 meeting were approved. Mr. Keller called for reports from Council.

The motion carried 5-0 by voice vote. This was assigned Ordinance No. ORD01-04. This constituted its first reading. Mr. Neal asked if the ordinance had been examined by the City Engineer and the Building Department. Mr. Waters stated that the Engineer, Mr. Kluesener had helped to draft the ordinance.

Council at Large – Mrs. Zech presented for its third reading ORD01-03, an ordinance *To Amend Sections 31.04 and 35.20 Of The Cheviot Code Of Ordinances*. Mrs. Zech made a motion to adopt ORD01-03. There was a second by Mr. Mestemaker. The motion carried 5-0 by roll-call vote and ORD01-03 was adopted.
