Motion carried with a 7-0 roll call vote.

Safety Service Director: Mr. Braun reported that municipal lot near Harrison and Glenmore will be closed for approximately 3 days for repair.

Law Director's Report: Thursday, July 11, the police labor contract factfinder suggested a mediation session to resolve an issue prior to the hearing.
