Meeting was called to order at 7:30PM by President Slaughter with the Pledge of Allegiance and a moment of silence. Roll was called and the following were found to be in attendance:

A motion to excuse Mr. Clark's absence was made by Mrs. Zech. Motion was seconded by Mr. Baker and carried with a 5-0 voice vote.

Motion to approve the minutes of the July 16 meeting was made by Mr. Dinkelacker with a second by Mr. Martin. Motion carried with a 5-0 voice vote.

Motion to approve the minutes of the August 20 meeting was made by Mr. Sunderhaus with a second by Mr. Martin.

Public Recognition: Mr. Neal addressed council with some questions regarding the garbage fee issue that will be on the November ballot.

Fire Chief Klein was called upon to recognize four new fire engineers: Eric Sullender, Steve Miller, Eddie Mercado and Eric Johansing.

Police Chief was called upon to introduce the police department's new hire, Andrew Linnig, who was then sworn into service by Mayor Keller.

Mrs. Zech presented her report from the Laws, Rules and Ordinances Committee meeting held on August 27. Motion to receive and file the report was made by Mrs. Zech with a second by Mr Dinkelacker. Motion carried with a 5-0 voice vote.

Mr, Dinkelacker presented his report from the Finance Committee's meeting held on August 27. Motion to receive and file was made by Mr. Dinkelacker with a second by Mr. Sunderhaus. Motion carried with a 5-0 voice vote.

Motion was made to move to executive session was made by Mrs. Zech, with a second by Mr. Martin, and a third by Mr. Dinkelacker. Council then entered executive session to discuss the FOP and AFSCME contracts.

Council meeting resumed at 8:40PM at which time Mr. Dinkelacker introduced Resolution 13-11 TO APPROVE A COLLECTIVE BARGAINING AGREEMENT WITH THE AMERICAN FEDERATION OF STATE COUNTY AND MUNICIPAL EMPLOYEES. The introduction was seconded by Mr. Baker and was adopted with a 5-0 voice vote.

Resolution 13-12 TO APPROVE A COLLECTIVE BARGAINING AGREEMENT WITH THE FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL, INC. was introduced by Mrs. Zech and seconded by Mr. Sunderhaus. Resolution was adopted with a 5-0 voice vote.

Resolution 13-13 TO APPOINT THE SAFETY SERVICE DIRECTOR AS THE CITY'S REPRESENTATIVE ON THE BOARD OF THE MERCY HOSPITAL JOINT ECONOMIC DEVELOPMENT DISTRICT, AND TO

DECLARE AN EMERGENCY was introduced by Mr. Sunderhaus and seconded by Mrs. Zech. Resolution was adopted with a 5-0 voice vote.

Ordinance 13-19 TO AMEND THE 2013 BUDGET APPROPRIATIONS, AND TO DECLARE AN EMERGENCY was introduced by Mr. Dinkelacker with a second by Mr. Martin. Introduction passed with a 5-0 voice vote. Motion to suspend the rules was made by Mr. Sunderhaus with a second by Mr. Baker. Motion carried with a 5-0 roll call vote. Motion to adopt was made by Mrs. Zech, with a second by Mr. Dinkelacker. Motion carried with a 5-0 roll call vote.

Ordinance 13-20 ORDINANCE REGARDING OPERATIONAL HOURS AT CHEVIOT PARKS was introduced by Mrs. Zech with a second by Mr. Baker. Following a 5-0 voice vote, this constitutes the first reading of this ordinance.

Mayor Keller had no report.

Safety Service Director Tom Braun had no formal report but reminded council of the Harvest Home Parade on September 5.

Law Director Mark Waters had no formal report.

Mayor's Court receipts from the month of August 2013 were presented. Motion to receive and file was made by Mrs. Zech with a second by Mr. Sunderhaus. Motion carried with a 5-0 voice vote.
