ORDINANCE NO. 15 - 30

TO AMEND THE 2015 ANNUAL BUDGET APPROPRIATIONS; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to meet certain unforeseen expenses, it has become necessary to adjust the 2015 annual budget appropriations; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The following budget line items shall be increased by the amounts indicated:

101.101.211.1	Police salaries – full-time	\$ 9,000.00
101.101.235.2	Police equipment maintenance	5,000.00
101.102.211.1	Fire Department salaries – full-time	15,000.00
101.506.235.2	Public Works equipment maintenance	8,000.00
<b>Total Increase</b>		<b>\$ 37,000.00</b>

Section 2. The following budget line items shall be decreased by the amounts indicated:

101.101.211.2	Police salaries – part-time	\$ 2,000.00
101.101.242.1	Police fuel, clothing, etc.	12,000.00
101.102.211.2	Fire Department salaries – part-time	15,000.00
101.506.235.2	Public Works fuel	8,000.00
<b>Total Decrease</b>		<b>\$ 37,000.00</b>

Section 3. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet its financial obligations in a timely manner.
