

**CITY OF CHEVIOT

**ORDINANCE NO. 20-21**

**TO AMEND THE 2020 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, it has become necessary to make adjustments to the appropriations of the 2020 annual budget by increasing and decreasing certain budget line items; and

**WHEREAS**, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:**

Section 1. The Budget Line Item No. 101.707.270.1 TAX DEPT. REFUNDS shall be increased by \$30,000.00.

Section 2. The Budget Line Items listed below shall be decreased by the amounts indicated:

Section 3. The sum of \$65,000.00 shall be transferred from the General Fund (No. 101) to the Police and Fire Pension Fund for pension payment.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
