**TO SUPPORT THE REPLACEMENT OF THE WESTERN HILLS VIADUCT; AND TO DECLARE AN EMERGENCY.**

WHEREAS, the Western Hills Viaduct is in disrepair; and

WHEREAS, Hamilton County is considering moving forward with the replacement thereof; and

WHEREAS, many citizens of the City of Cheviot utilize the Western Hills Viaduct daily in their commute and travels; and

WHEREAS, it is in the greater public interest to maintain all public right of ways to assure safe travel; and

WHEREAS, the City desires to add its voice calling for the replacement of the Western Hills Viaduct.


**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**

Section 1. On September 5, 2017 in an open meeting Council discussed lending its voice to concerns regarding the deterioration and condition of the Western Hills Viaduct.

Section 2. The City of Cheviot Council supports the efforts of other governmental divisions and agencies to move forward with the replacement of the Western Hills Viaduct.

Section 3. Upon passage, the Clerk of Cheviot City Council shall forward a copy of the resolution to the Hamilton County Commissioners.

Section 4. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to timely express support of the viaduct replacement.
