Re: Year-end Police Department Activity Report

During the calendar year of 2018, The Cheviot Police Department received 5129 calls for service from the Hamilton County Communications Center. Not included in that number were 1930 self-initiated/ non-billed details for a total of 7059 responses for service. Officers logged a total of 13539 entries, for the year of 2018 into our Pamet reporting system. These additional entries represent extra jobs, building checks, vacation checks, business checks, self- initiated details, details called into the station, directed patrol etc.

Officer Commendations

Sgt. Dietrich / Sgt. Ehler received a Letter of Commendation from Judge Martin reference an arrest and conviction on a Robbery charge.

PO. Wagoner / Sgt. Holder received a Letter of Commendation from Chief Stone reference their tireless efforts and citation involving a pedestrian struck by a school bus. The bus left the scene.

Sgt. Patton / Det. Goff / PO. Wagoner received a Letter of Commendation from Chief Stone reference their valuable assistance in locating and recovering a 2- year old child who was kidnapped in Harrison Ohio. In addition, several charges were filed against the 4 perpetrators involved in the crime.

Information of note

The Cheviot Police Department applied and received a grant through the Ohio Attorney General's Office, which was sponsored by Workman's Comp. We were able to secure the

purchase of hard/heavy body armor (armor used to stop high powered rifle rounds) utilized for making entry into a high- level critical incidents involving a shooter. We were able to secure a 75% match for the vest purchases. This brought Cheviot's contribution to \$4654.30 while the grant matched \$13,962.90.

In the last quarter Det. Goff was nominated to the HCPA Officer of Year award for his investigation, arrest and conviction of Nicolas White (Rape, Child Pornography) and Elizabeth Smith (Complicity to Rape and Endangering Children). Det. Goff received an Honorable Mention for his efforts. Subsequently, a nomination was also submitted to Cincinnati Citizens Police Association. He was awarded Officer of the Month. He accepted his award at a recent luncheon at the Queen City Club.

The Cheviot Police Department attended 1334 hours of job relating training for the year of 2018.

Our RMS (Pamet) is currently up and running. Our records from Spring of 2014 through Fall of 2018 are still missing. Securas Technologies continues to work on the problem.

Cheviot officers logged 667 hrs of training for the 2018 calendar year.
